# HOMEOWNERS' ASSOCIATION, INC. POOL RULES & AMENITY GUIDELINES

These are private amenities for the exclusive use of residents in good standing with the Sundance Homeowners' Association and their guests.

NO TRESPASSING – violators will be prosecuted.

## general pool rules:

#### In order to use the Amenity Center the following qualifications must be met:

- 1. Homeowner must be current on all Association dues and fees. Fees must be paid in full ten (10) days prior to issuance of the access card.
- 2. Member must use his/her access card to gain entry into pool area and to enter adjacent facilities.
- 3. Must be a resident Member and/or guest of a resident Member who is present.
- 4. Must provide identification if requested.
- 5. SWIM SCHEDULE set from 19 March to 25 September from 8 am to 10 pm. Pool closed on Mondays for cleaning.
- 5. SWIM SCHEDULES are subject to change and will be posted on the Association's Website: www.sundancehoa.com

# NO DIVING, RUNNING, HORSEPLAY, FIGHTING OR ANY OTHER DANGEROUS PHYSICAL ACTIVITY.

- 1. NO SMOKING IN THE GATED POOL AREA.
- 2. NO DIAPERS EXCEPT SPECIAL SWIM DIAPERS.
- 3. NO ALCOHOL.
- 4. NO GLASS CONTAINERS.
- 5. NO FOOD, DRINKS OR GUM IN THE SWIMMING POOL.
- 6. PLEASE WAIT 30 MINUTES BEFORE SWIMMING AFTER EATING.
- 7. NO FOUL OR VULGAR LANGUAGE OR LOUD NOISE WILL BE TOLERATED.
- 8. NO ROLLER/IN-LINE SKATES, SCOOTERS, SKATEBOARDS OR BICYCLES IN THE GATED POOL AREA OR PARKING LOT.
- 9. ONLY **SMALL** PERSONAL FLOTATION DEVICES AND WATER TOYS.
- 10. NO ANIMALS IN THE POOL AREA (EXCEPT SERVICE ANIMALS).
- 11. CHILDREN UNDER THE AGE OF SIXTEEN (16) MUST BE ACCOMPANIED BY AN ADULT AT ALL TIMES. AN ADULT IS DEFINED AS A PERSON OF AGE EIGHTEEN (18) OR OLDER.
- 12. MEMBERS MAY HAVE A MAXIMUM OF FOUR (4) GUESTS PER HOUSEHOLD.
- 13. A GUEST CANNOT BE A DELINQUENT MEMBER OF THE ASSOCIATION COMMUNITY.
- 14. ALL MEMBERS AND GUESTS ARE EXPECTED TO ABIDE BY THE POOL RULES AT ALL TIMES.
- 15. MEMBERS SHALL BE RESPONSIBLE FOR THEIR CHILDREN, GUESTS, AND SHALL ASSUME LIABILITY FOR THE ACTIONS OF THEIR CHILDREN AND GUESTS.
- 16. LOST OR STOLEN ACCESS CARDS MUST BE REPORTED TO MANAGEMENT COMPANY WITHIN 24 HOURS. FEES WILL APPLY.
- 17. ADDITIONAL CARDS AND REPLACEMENT CARDS ARE SUBJECT TO \$50 FEE.

ASSOCIATION AND MANAGEMENT ARE NOT RESPONSILE FOR ANY LOST OR STOLEN ITEMS, AND/OR ANY ACCIDENTS OR INJURIES.

## FOR SERIOUS INJURYOR LIFE THREATENING EMERGENCY ASSISTANCE CALL 911.

THE POOL MUST BE CLOSED IF THERE IS THUNDER AND/OR LIGTENING IN THE VICINITY.

#### SECURITY AND GUEST POLICY

- 1. The Association reserves the right to not grant access to the pool to any resident or guest without their access pool card and valid identification. NO EXCEPTIONS
- 2. A Member shall accompany their family and guests at all times.
- 3. Removal of Association equipment, furniture or accessories is strictly forbidden.
- 4. Report any unsafe or unpleasant activity to RealManage at (866) 473-2573 or email sunsana@ciramail.com.
- 5. The Association reserves the right to revoke pool privileges to any resident or guest who has delinquent association fees.
- 6. Residents are responsible for any damages to the pool area resulting from a lost and/or stolen card.
- 7. Report lost or stolen or magnetic key cards immediately to RealManage at (866) 473-2573; the replacement fee for lost and/or stolen cards is \$50

#### PARENTS ARE DIRECTLY RESPONSIBLE FOR THE ACTIONS OF THEIR CHILDREN.

#### **BABY POOL RULES**

- 1. Minors must be accompanied by parent or guardian eighteen (18) years of age or older and must be within arm's reach at all times.
- 2. Parents or guardians are responsible for their children.
- 3. All pool rules apply to the baby pool.
- 4. Swimsuits are required. Disposable diapers are not allowed. "Little swimmers" or plastic/rubber underpants are recommended.
- 5. Only non-swimming, pre-school children five (5) years of age or younger may use the baby pool.

Members and their guests understand that they must comply with the Recreation Use Guidelines. The Association shall not be responsible for any personal belongings left in the Recreation Center. The Association shall not be responsible for the actions of its members or their guests. The Association shall not be responsible or liable for any physical injuries, property damage, or loss suffered by members, their children, or their guests during their use of the Recreation Center.
